Minutes of the Community & Environment Committee Meeting held on Tuesday 12 November 2024 in the Council Chamber, Town Hall.

A/24/1705 Apologies for absence

A/24/1706 Variation of Order of Business

Cllr Mrs Brown asked that a letter be sent to DCC and DDDC regarding the unlawful encampment in Ashbourne. It was RESOLVED to add this as agenda Item 9 (a)

The Clerk asked that an additional item relating to Christmas 2024 event: assistance with getting barriers out of the cellar on Thursday for the event on Saturday 16 November

It was RESOLVED to add this as agenda item 7(h)

A/24/1707 Declarations of Members Interests

None received

A/24/1708 To receive and approve requests for dispensations from members on matters in which they have a Disclosable Pecuniary Interest

A/24/1709 Public Questions and Comments – (3 Minutes per speaker a maximum 15 Minutes in total)

Cllr Moore stated that the grit bin on Lodge Avenue green space had been cleared of water and rubbish; however, a resident had asked that it remain. Cllr Moore suggested leaving it in situ for this winter to see if it was used

Cllr Bates stated that an email had been circulated to DDDC ward members advising that the responsibility of evicting the travellers was the responsibility of DCC as it was their land. He added that an eviction notice had been sought; however, it would take a while to enforce.

Cllr Bates stated that the Levelling Up works would start on the 6 January; and St John Street would be closed for 19 weeks starting after Shrovetide

Cllr Mrs Brown asked that residents concerns regarding the works to Henmore Bridge be raised with Ashbourne Reborn

A/24/1710 Presentation by FoAP on their proposed 'tree lined walkway' across the recreation ground

Mr Clayton thanked members for the opportunity to give the presentation; he stated that the proposal had been circulated to all members. Mr Clayton explained how and why the idea has evolved following meetings with groups who use the recreation ground on a regular basis. Mr Clayton said that the proposal had been costed and £15,000 had been offered by Ashbourne Partnership Trust and the remaining money be raised through a go-fund me page.

Members raised questions and concerns about whether the tree-lining of the path; including whether it would impact on the proposed extension to the pavilion or on Town Council events held on the space.

The Assistant Clerk asked why Ashbourne Partnership Trust were insisting on the path being tree-lined, and that when the path is put in place it would show whether the ground was suitable for planting and growing trees: Mr Warren stated that they wanted it to be part of the heritage of Lady Cokayne.

Mr Clayton stated that FoAP were looking for the Town Council's support of their proposal.

It was RESOLVED that a letter supporting the proposal in principle be agreed.

A/24/1711 Christmas 2024 update on the event

a) Members to note that all Town Council events are to be marshalled by Councillors as per the Risk Assessment and Insurance

The Clerk advised that it was noted that fewer Councillors were assisting with marshalling Town Council events: and if this is likely to be the case going forward the Risk Assessment and Insurance would have to be altered to reflect it.

Members questioned what affect this might have; it was noted that additional security may be needed which would have an additional cost. Members RESOLVED to adjust the Risk Assessment and Insurance to show eight (8) Councillors as marshalls for the event

- d) Members to confirm availability to assist with food vendor locations (appx 4.30pm on the night)

 Cllr Clark suggested that some-one should be appointed as a co-ordinator based in the Town Hall and advise Members where assistance was required
- e) Members to advise availability to assist with putting out road closure, diversion signs and barriers (5.00pm on the night)

Cllr's Mr E Brown; Mr P Chell; Dr G Clark; Ms B Michalek and Ms S Moore and stated that they would assist with putting out road closure, diversion signs and barriers in place at 5.00pm on the night

A/24/1714 Cllr Mrs Brown – Consideration of writing to DCC and DDDC in relation to the travellers on Watery Lane

Cllr Mrs Brown asked that the following be sent to DCC and copied to DDDC.

Ashbourne Town Council strongly recommend that DDDC & DCC commence legal action to evict the travellers illegally camped on the old highway's depot, Watery Lane, Mayfield Road, Ashbourne. Ashbourne Town Council is led to believe that the travellers unlawfully accessed this site by breaking and entering. The process for an eviction notice needs to be started immediately along with police action for breaking into the land. Ashbourne Town Council would like to be kept updated with when the process is started.
