## F/24/1673 a) Ashbourne Town Team to present the case relating to their 'application for funding' of £5,000.00 towards 'stage 3' of the Business Improvement District (BID) for Ashbourne

Mrs Wright gave an overview of the Business Improvement District (BID) for Ashbourne; she added that the Town Team were looking for £5,000.00 toward 'stage 3'; which was the ballot, and that the ballot would only take place if stages 1 and 2 were successful.

Ms Hough said that she had worked for 'Groundwork' since the early 2000's and was involved in the first 'BID' in the UK.

Ms Hough gave a slide show presentation explaining how 'Groundwork' has been involved in BID for other Council's and what they had achieved.

b) Members to consider and decide on the funding request of £5,000.00 under the Power of S137. If agreed the money is to be ringfenced specifically for Stage 3 of the 'BID' the ballot stage and due for payment in the latter half of 2025. If the BID does not reach the ballot stage the funding will be re-allocated to other TC expenditure

# F/24/1674 a) Presentation by Ashbourne Sports and Community Partnership (ASCP) relating to their offer for the Town Council to become a community investor in ASCP projects which make a difference to the residents of Ashbourne

Mr Lake said that ASCP wanted to present two opportunities to the Town Council: the proposed extension to the pavilion and the 3G Pitch.

Mr Nye gave a slide show presentation on the proposed extension to the pavilion including a 3D projection of how it could look. The extension would be to the side of the existing building and include a large function room and rooftop space.

Mr Golding said that there was the demand for a 3G Pitch, which would be sited on the existing hockey pitch, it would provide an all-weather facility and was supported by DDDC and the Football Foundation however there was a shortfall of between £400,000 and £500,000.
