HIGHWAYS ACT 1980

RE: DISEASED ASH TREES ON LAND AT BRADLEY WOOD, ADJOINING THE SOUTH SIDE OF A517 BELPER ROAD, NETHER STURSTON, DERBYSHIRE.

I write to inform you that a group of approximately 5 Ash trees on land adjoining the A517, which we believe you own, appear showing advanced signs of Ash Dieback disease. The trees are in a poor condition and as such is posing a risk to the highway. I enclose a report by one of our Tree Inspectors which identifies the location of the trees in question with tree ref: **Tg1**. The schedule at the end of the report sets out a specification of work that is recommended to be carried out to all the trees within **6 months**.

If the recommended work is not undertaken within this timescale, the County Council may decide to serve a formal Notice on you under Section 154 of the Highways Act 1980 that will require you to carry out the recommended work within 14 days of the Notice. To avoid such formal action, it is hoped that your co-operation can be relied upon to carry out the recommended work as soon as possible, but certainly within the timescale referred to above. I enclose a form for you to complete and return to confirm that the recommended works has been carried out.

The trees are not protected by a Tree Preservation Order made by the County Council, however they might be protected by a Tree Preservation Order made by the District/Borough Council or be within one of their Conservation Areas. As such, it would be advisable to contact the planning department at the District/Borough Council as you may be required to obtain their written consent before carrying out the recommended work. If protected, you may also have a legal duty to plant replacement trees, and you are advised to discuss this with the District/Borough Council when you contact them.

Please be advised that you may also require a Felling License from the Forestry Commission before carrying out the work. You can find more information about obtaining a felling license here: https://www.gov.uk/guidance/tree-felling-licence-when-you-need-to-apply#whocan-apply-for-a-licence. Whilst certain exemptions from the requirement to obtain a Felling License may apply, it is your responsibility

to confirm this directly with the Forestry Commission prior to carrying out the work. Contact details for their East and East Midlands Regional Office can be found here: https://www.gov.uk/government/organisations/forestry-commission/about/access-and-opening#east-and-east-midlands.

Please find enclosed two Advice Notes concerning the potential for bats or nesting birds within the trees and you should have regard to the advice in these notes when carrying out the recommended work.

General notes:

Ash tree is showing symptoms of Ash Dieback disease caused by the fungus Hymenoscyphus fraxineus. Ash dieback is widespread across England and Ash trees across Derbyshire are now symptomatic of the disease. Symptoms vary, but include leaf wilt, leaf loss and crown dieback, and in some instances visible lesions in branch or stem tissues which directly contribute to tree decline and death.

Infected trees are known to be weakened to the point where they succumb to secondary pests or pathogens. As an ash tree declines it will become brittle, lose branches, and eventually succumb to the disease. Where affected by secondary pathogens, it appears to decline more rapidly, increasing the loss of timber strength and integrity increasing the likelihood of structural failure.

The visual condition of the crown density can be broken down into four categories:

- Category 1: 100%-76% of the crown remains
- Category 2: 75%-51% of the crown remains
- Category 3: 50%-26% of the crown remains
- Category 4: 25%-0% of the crown remains

Category 1 is for trees in good- fair condition, with no, or minor symptoms of infection. Category 4 is for trees in poor condition, with advanced symptoms of infection.

Removal of the worst affected ash trees is currently recommended (category 4), and the continuing inspection of any retained Ash trees will be required.

Please be aware that landowners are legally responsible for trees that are on their land and that regular inspection of any retained trees by the landowner is advised.

Removal of the tree is recommended to prevent branch or whole tree failure onto the highway.

Works recommended:

- Please see the Tree Schedule in appendix 1 for the relevant tree work recommendations
- All works to be carried out to British Standard 3998:2010 (BSI)

PLEASE NOTE:

Individual landowners are permitted to fell 5m³ per calendar quarter without a felling license if the timber produced is not to be sold, and 2m³ if the timber produced is to be sold.


Landowners receiving this report will need to check with their local Forestry Commission woodland officer if felling licenses are required for their trees as well as checking for District Council tree preservation orders (TPO) and Conservation areas. Potential ecological constraints will also need be assessed before carrying out works (Nesting birds, bat roost potential, etc).

Advice Note: Nesting Birds

- 1. Nesting birds are protected by the Wildlife and Countryside Act, 1981, Part 1, Section 1(1).
- 2. It is an offence to intentionally or recklessly:
 - a. Kill, injure or take and wild bird;
 - b. Take, damage or destroy its nest whilst in use or being built;
 - c. Take or destroy its eggs.
- 3. The nesting season for birds is from March to August inclusive although it is impossible to give exact dates. Therefore, work should not be undertaken to trees and hedges between April and July unless there are immediate road safety issues.
- 4. Ideally landowners should inspect their trees and hedges in the autumn and manage them in winter (November to February) to avoid both nesting and feeding seasons.
- If you are instructed to carry out tree or hedge maintenance by the
 Highway Authority during the summer you must check thoroughly for
 nests. If nests are present work must not proceed and you should advise
 the County Council immediately.

Advice Note: Bats and tree work

- 1. All species of bat are protected by the Wildlife and Countryside Act (as amended) 1981 and the Conservation (Natural Habitats & C) Regulations 1994, known as the Habitat Regulations.
- 2. It is an offence to intentionally or recklessly:
 - a. Damage, destroy or obstruct access to any place that a bat uses for shelter or protection.
 - b. Disturb a bat while it is occupying a structure or place that it uses for shelter or protection.
- 3. Where the presence of bats is suspected a bat survey should be undertaken. If it is concluded that it is unlikely that bats are present and works can proceed care should still be taken.
- 4. If bats are found and the branch has already been removed or tree felled gather any bats that have fallen out of the cavity and put them into a dark confined space such as a cardboard box and contact English Nature immediately.
- 5. If bats are found in a cavity within a felled section; cover the section and put it to one side and contact English Nature immediately.
- 6. As bats and their roosts are protected, failure to take the appropriate action could result in prosecution. If in doubt, contact English Nature for advice.
